This summer, our school achieved its 'BEST EVER' set of examination results and we are extremely proud of our students' achievements. At this point, I would like to thank our dedicated and professional staff for their hard work in supporting the students' success. In addition, I would like to thank our parents and guardians who supported both the school and the students in achieving these very impressive results.

The key performance measures demonstrate how well we did last year:

- 5A* C including English and Maths results were, 66%. This is a 25% increase on the previous year and is above national Average.
- Progress 8 figures show that we are well above the National Average and that our students do better than most given the same starting point.
- English, 75% A* C which is well above national Average.
- Maths 75% A* C which is well above national Average.
- in addition, the following subjects also achieved above national Average and above 70% A*
 C; Art, biology, Chemistry, Computer Science, iCT ECDL, Physical Education, Physics and Science bTEC.

Ensure that you make it clear what time you are collecting your child, or that they can make their own way to the appointment and what time you expect them to return to school. if school have not been advised of an appointment, reception will call parents/guardian to confirm and children will not be allowed to leave school premises until contact has been made.

Geography Field Trip

Over two days in July, our Year 11 students set their alarm clocks early, dug out their wellies and travelled to Carding Mill Valley in Shropshire located on the Welsh border.

The students first went to the Field Studies Centre, where they spent an hour in the classroom researching the theory behind their Controlled Assessment title. After this, they were kitted out with waterproofs and set off to the river.

Throughout the day, the students had to measure a range of variables including the width and depth of a river, the river's velocity and identify how the bed load had changed. All of our students worked really well together and collected some excellent data to be used for their Controlled Assessments.











The Botanical Gardens

Six of our students recently visited The Botanical Gardens in Birmingham to find out about a project to design a garden; they were all extremely well behaved, enjoyed the tour, listened to all of the information and history of the plants kept there and took pictures to input into their project. All of the students represented TQEA very well.

Since then, back at school, they have been working with both the iT and Art departments to structure their project plans and to produce digital and 3D models of their garden vision as it takes shape.

Our team has had Craig Leddington, assigned to their group as the mentor for the rHS challenge, he is a senior groundsperson at Webb's Garden Centre in Wychbold. Craig started there 15 years ago for weekend work, got a chance to move to the ground's team for summer help and was offered a job when he was finishing university, so took it whilst deciding what to do, and that was 10 years ago! Wychbold is a 50 acre site, where Craig's main duties include planning and maintaining the bedding displays along with the general gardening duties in the upkeep of 5 acres of gardens, play area, car park and the grass entrance areas. This means lots of watering, hedge cutting, mowing, pruning and weeding!

Together with Craig and our gardening club leaders Mrs Hale and Mrs Knight, the team are hoping to design a prize winning garden planned and modelled to perfection over the next few weeks.














ART

Requests for Holidays in **Term Time**

The recent and highly publicised case of isle of Wight v Platt has not changed the law in relation to authorising a Leave of Absence (LoA). This is still a matter for the school's discretion, and LoA can still only be authorised where there are deemed to be exceptional circumstances relating to that application.

The school will refer all unauthorised absences to the ACE service at the Local Authority and they, not the school, will then make a decision on whether a Fixed Penalty is to be issued.

Please be aware that the Local Authority **ARE** still issuing Fixed Penalty notices of £60 per parent, per child. There have been two issued already this academic year. Please also be aware that all monies claimed by the local authority are retained by them.

LEAVE OF ABSENCE DURING TERM TIME 2016-17 INFORMATION FOR PARENTS

The Education (Pupil registration) (England) (Amendment) regulations 2013, govern all requests for leave within term-time. When considering such requests for a leave of absence, the school are obliged to act within the law.

The amended regulations removed references to 'holiday' and 'extended leave', as well as the statutory threshold of 10 school days. it is now clear that Head Teachers may not grant any leave of absence during term time unless there are exceptional circumstances relating to the application. if the leave is granted, head teachers are able to determine the number of school days a child can be absent for.

The Government has not defined 'exceptional circumstances' as referred to in the 2013 regulations. It is for the Head Teacher to decide what he/she views as 'exceptional' and it is at their discretion if the circumstances warrant the leave to be granted. The school can only consider Leave of Absence requests which are made by the 'resident' parent. Each application for a leave of absence will be considered on a case by case basis and on its own merits.

Where applications for leave of absence are made in advance and refused, the child will be required to be in school on the dates set out in the application. if the child is absent during that period, it will be recorded as an unauthorised absence, which may result in legal action being taken against the parent(s), by way of a Fixed Penalty notice.

Failure to make an application for leave in advance can also result in a Fixed Penalty notice being issued to the parent(s).

All matters of unauthorised absence relating to a Leave of Absence will be referred to the Attendance, Compliance and Enforcement Service of Warwickshire County Council.

It is important to note, Fixed Penalty notices are issued to each parent of each absent child, (for example 2 children and 2 parents, means each parent will receive 2 invoices in the amount of £120 each, totalling £240 for both children, this is reduced to £60 per child if paid within 21 days).

Where a Fixed Penalty notice is not paid within the required timeframe as set out on the notice, the matter will be referred to Warwickshire County Council's Legal Services to consider instigating criminal proceedings under S444 Education Act 1996.

Fixed Penalty Notices are issued in accordance with Warwickshire County Council's Code of Conduct for Penalty notices.

Warwickshire Secondary School pupils recorded 15,291 half day sessions of absence due to holiday in the Academic year 2014/15. This is a decrease of 7,629 on previous years. This is a positive outcome as it means that 3,814 days of education was achieved.

We greatly appreciate parental support to reduce the total amount of days lost due to holidays. We are committed to working in partnership with you to enable your child to reach their academic targets and to support their social development. For this to happen we need to keep individual attendance as high as possible - we all need to play our part.

Your child's progress academically as well as socially is our shared priority

Where applications for leave of absence are made in advance and refused, the child will be required to be in school on the dates set out in the application. if the child is absent during that period, it will be recorded as an unauthorised absence, which may result in legal action being taken against the parent(s), by way of a Fixed Penalty notice.

Failure to make an application for leave in advance can also result in a Fixed Penalty notice being issued to the parent(s).

Where a Fixed Penalty notice is issued and not paid within the required timeframe as set out on the notice, the matter will be referred to Warwickshire County Council's Legal Services to consider instigating criminal proceedings under S444 Education Act 1996.

Parents are asked to respect the new regulations under which the school must work and if there is a need to take a child out of school during term-time, an application or request must be made in advance and make clear how the circumstances are exceptional. http://www.tqea.org.uk/attendance
