Dear Parents and Carers,

This week we had an academy review from our Trust leaders in the Academy Transformation Trust. One of the huge advantages of being part of the ATT family is the huge opportunities it affords for our academy to learn from best practice and, as a result, to improve rapidly. In this review we were joined by Garry Trott (Acting Director of Secondary Education), Kully Uppal (Principal of Bristnall Hall Academy), Tom McDowall (Principal of Pool Hayes Academy) and Derek Trimmer (National Education Director).

The purpose of the day was to establish where TQEA is with its school improvement progress by undertaking conversations with students, deep dives in several subject areas, reviewing our teaching, learning and curriculum and to review student behaviour. In total 8 subject areas were reviewed.

On these occasions I am always proud of our students, our academy and our community. I am very vocal about our role as a community school, the only secondary school in the town of Atherstone. I also very proudly explain how wonderful our students are and promote our core values and vision. It is also important during these reviews to explain our improvement journey as an Ofsted "Good" academy with high expectations and aspirations for all of our students.

From the moment the team arrived they were met by Adam, our Head student in Year 10, who escorted the reviewers from the car park to reception. On the way Adam spoke proudly of our academy and talked about the brilliant work the student leadership team did.

The reviewers were very complimentary about the uniform, the manners, the behaviour and the conduct of our students. They enjoyed speaking to them about our academy and about their learning. Our students are a huge asset to the academy and they did us proud once more!

The review went well with the team confident that the students at TQEA get a good deal. In particular the team were struck by the improvements in learning and behaviour, our expectations and standards and in our excellent curriculum offer for students (including our extended day after school clubs). They were also pleased with our plans to improve our Careers provision with a stronger focus on Careers advice earlier in the programme. One of the new initiatives in this area is our year 11 mock interview process led by 13 local business people. A fantastic learning opportunity for life!

The review gave the leadership team a very clear focus on where further improvements on our improvement journey should be made and we will now work hard to make those improvements to benefit our students more!

Is your child eligible?

One of the effects of the COVID 19 Pandemic is the changes to our home and financial situations.

If your financial situation has changed and you receive of any of the following your child may be able to get free school meals;

Income Support Income-based Jobseeker's Allowance Income-related Employment and Support Allowance Support under Part VI of the Immigration and Asylum Act 1999 The guaranteed element of Pension Credit Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190) Working Tax Credit run-on - paid for 4 weeks after you stop qualifying for Working Tax Credit Universal Credit - if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)

If your child is in any of the following categories, the school can apply for extra funding through the Pupil Premium programme which will enable us to provide additional support and resources to benefit your child's education at TQEA: Pupil

In receipt of Free School Meals A looked after child A previously looked after child A child with a parent currently serving in HM Armed Forces. A child with a parent who is retired with a pension from Ministry of Defence. A child who has been adopted

If any of the above situations applies to your family due to a change in circumstances and we are not already aware, please contact the school and we can assist you further.

Families who are already in receipt of Free school meals and Pupil Premium funding will shortly be receiving a survey from TQEA to assist with our support package this year. We would be grateful if you could complete the survey and return to the school.



LEAVE OF ABSENCE DURING TERM TIME UPDATED INFORMATION FOR PARENTS

The Supreme Court recently reached a decision in the case of Platt v Isle of Wight Council which has clarified the law on unauthorised leave, including holidays, during term time. The parents of children of compulsory school age are required to ensure that they attend school on a regular basis. The Supreme Court has made clear that attending school 'regularly' means that the children must attend school on every day that they are required to do so. As such, the parents of any child who is absent from school without authorisation for any length of time are likely to be considered as committing an offence under s444 of the Education Act 1996.

Head Teachers retain the ability to authorise leave in accordance with the Education (Pupil Registration) (England) Regulations 2006. When considering such requests for a leave of absence, the school are obliged to act within the law. Head Teachers may not grant any leave of absence during term time unless there are exceptional circumstances relating to the application. If the leave is granted, head teachers are able to determine the number of school days a child can be absent for.

It is for the Head Teacher to decide what is 'exceptional' and it is at their discretion if the circumstances warrant the leave to be granted. The school can only consider Leave of Absence requests which are made by the 'resident' parent.

Each application for a leave of absence will be considered on a case by case basis and on its own merits.

Where applications for leave of absence are made in advance and refused, the child will be required to be in school on the dates set out in the application. If the child is absent during that period, it will be recorded as an unauthorised absence, which may result in legal action being taken against the parent(s), by way of a Fixed Penalty Notice.

Failure to make an application for leave in advance can also result in a Fixed Penalty Notice being issued to the parent(s).

All matters of unauthorised absence relating to a Leave of Absence will be referred to the Warwickshire Attendance Service, part of Warwickshire County Council

It is important to note, Fixed Penalty Notices are issued to each parent of each absent child, (for example 2 children and 2 parents, means each parent will receive 2 invoices in the amount of £120 each, totalling £240 for both children, this is reduced to £60 per child if paid within 21 days).

Where a Fixed Penalty Notice is not paid within the required timeframe as set out on the notice, the matter will be referred to Warwickshire County Council's Legal Services to consider instigating criminal proceedings under S444 Education Act 1996.

Fixed Penalty Notices are issued in accordance with Warwickshire County Council's Code of Conduct for Penalty Notices.
